WEEKLY FRYERS AVAILABLE FOR MARKETING

Based on the preliminary chick placements, the number of fryers available for marketing during the week ending 18-Jun-11 is estimated at 159.5 million head. This compares to 159.2 million head the previous week and to 160.8 million head the same week a year ago, when the slaughter was 163.9 million head and the composite weighted average price was 86.07 cents per pound.






