National Egg Review

This week New York prices are higher for extra-large and large, steady for medium. Early in the week, regional prices increased for the larger sizes



and decreased for mediums. Next week's regional asking prices are trending higher for the heavier weight eggs and steady for the lighter weights. The undertone is steady to firm. Retail demand ranges light to good, mostly moderate to good. Food service demand remains light to moderate. Offerings are light for jumbo and extra-large, moderate for large, and moderate to instances heavy for medium. Market activity is moderate. Breaking stock prices are mixed with checks and undergrades steady. The undertone is steady. Demand is light to instances moderate. Offerings are light to mostly moderate. Supplies are light to moderate. Market activity is slow to moderate. North Central regional light type hen removal costs are steady. Demand is moderate to fairly good with offerings light. Schedules are full-time. Market activity is moderate.

WEEKLY FRYERS AVAILABLE FOR MARKETING

Based on the preliminary chick placements, the number of fryers available for marketing during the week ending 23-Jul-11 is estimated at 158.0 million head. This compares to 158.8 million head the previous week and to 162.9 million head the same week a year ago, when the slaughter was 165.0 million head and the composite weighted average price was 88.03 cents per pound.






