Feed corn is selling at startlingly high prices, which could be signaling that the U.S. will run short of corn this summer, according to *Reuters*. Prices on the cash market have been unusually high for months. They are well above Chicago futures prices and much higher than historically at this time. In central Illinois, the basis was 53 cents a bushel above futures prices on June 4, half a dollar higher than a year ago.
