New Management Measures for Atlantic Sea Scallops

NOAA Fisheries announced quota reductions and the continued closure of two special access areas for the 2013 and 2014 Atlantic sea scallop fishery. The scallop industry supports these measures, which are intended to protect young scallops and maximize future harvest.

NOAA Supports Free Access for St. Croix River Herring

In March, NOAA reaffirmed its support for unfettered access for river herring in the St. Croix River before the Maine State Legislature's Joint Standing Committee on Marine Resources. A new state law now requires unconstrained fish passage on this river.

By **June 7**, [submit your comments](#) on NOAA Fisheries' proposed rule to implement Amendment 18 to the South Atlantic Snapper-Grouper Fishery Management Plan. These changes would reflect the findings of updated population assessments for vermillion snapper and red porgy.

Proposal Aims to Reduce Shark Attacks on Monk Seals

At certain islets in the Northwest Hawaiian Islands, endangered Hawaiian monk seal pups are at particular risk of predation by Galapagos sharks. The Pacific Islands Fisheries Science Center's Hawaiian Monk Seal Research Program has submitted a permit request to continue its efforts to mitigate predation threats.
