### **NOAA Scientists Document New Walrus Haulout**

Every year, a team from NOAA Fisheries' Marine Mammal Lab surveys the Alaskan Arctic from small airplanes to study the distribution and abundance of marine mammals. This summer, NOAA scientists were the first to document from the air thousands of walruses lounging on the shore near Pt. Lay, Alaska. The scientists were able to provide valuable data to partner agencies.

### **Snapper-Grouper Amendment - Please Comment**

By **October 28**, [submit your comments](#) on a proposed rule to implement Amendment 27 to the South Atlantic Snapper-Grouper Fishery Management Plan (FMP). The rule would make several changes intended to streamline management of Nassau grouper, improve vessel safety, implement consistent regulations on retention limits, and minimize impacts to blue runner fishermen.

## Alaska

### **Larger Vessels in Pacific Cod Fishery - Please Comment**

By **November 29**, submit your comments on a proposed amendment to the Groundfish of the Bering Sea and Aleutian Islands Management Area Fishery Management Plan. Amendment 99 would encourage replacement of older vessels by allowing certain license limitation program (LLP) license holders to use new or existing vessels not eligible under current length and capacity restrictions.
