NOAA Fisheries Unveils Social Indicators Map Tool

NOAA Fisheries has developed a new, user-friendly web-based mapping tool that will allow managers and other stakeholders to assess the vulnerability and resilience of coastal fishing communities along the Atlantic and Gulf coasts. The tool maps and compares social indicators—measures of social, economic, and psychological well-being—for nearly 3,000 communities in 19 states.

Lobster Area Control Date - Open for Public Comment
By **February 26**, submit your comments on the announcement of a control date for Lobster Conservation Management Areas in the Atlantic. NOAA Fisheries and the Atlantic States Marine Fisheries Commission will consider if and how participation in the American lobster fishery should be controlled.

Fishing Year 2012 Groundfish Fishery Report
NOAA Fisheries released the third annual report on the economic performance of the vessels active in the Northeast groundfish fishery. This report for the 2012 fishing year provides additional analysis on the landings and revenue figures that were made available to the public last September.

Public Input Sought for Gulf of Mexico Data Atlas
NOAA's Gulf of Mexico Data Atlas, launched in 2011, provides 235 map plates of datasets covering more than 70 topics relevant to the Gulf ecosystem. Now, NOAA is working with Mississippi-Alabama Sea Grant to evaluate the usability of the data atlas and to gather input for the next upgrade. Check it out and share your thoughts.

West Coast

[Strategies for Sacramento Winter Chinook - Open for Public Comment](#)

By **April 23**, submit your comments on a management strategy evaluation conducted for a suite of alternative harvest control rules for Sacramento River winter Chinook salmon. The Pacific Fishery Management Council requested that NOAA Fisheries consider *de minimis* harvest scenarios for years of low winter-run abundance.

Alaska

[Gray Whale Calf Sightings Increase in Alaskan Arctic](#)

Each spring, a population of gray whales migrates up the western coast of North America to its summer feeding grounds in the northern Bering and Chukchi Seas. Aerial surveys in 2012 and 2013 noted more sightings of gray whale calves than in previous years, and NOAA scientists are working to determine the cause of the increase.

[Foraging Habitat Segregation by Northern Fur Seals](#)

The largest breeding colony of northern fur seals in the United States is located on Alaska's Pribilof Islands. Research in the 1990s found that the seals geographically segregated the habitat surrounding the islands when foraging, perhaps to reduce competition for food. Recently, scientists re-examined whether declines in the seal population have reduced competition and likewise the need to segregate foraging habitat.
