#### [2014 Regional Fishery Council Appointments](#)

The U.S. Department of Commerce announced the appointment of 22 new and returning members to the eight regional fishery management councils that partner with NOAA Fisheries to manage the nation's ocean fisheries. Every year, about one-third of council members are appointed to 3-year terms.

NOAA Fisheries and the U.S. Fish and Wildlife Service announced a new policy clarifying the interpretation of the phrase "significant portion of its range" in the Endangered Species Act as it applies to decisions to list species as threatened or endangered. The policy will provide consistency in the application of the phrase.

### **Construction of New Replacement Fishing Vessels - Request for Comments**

This week, NOAA Fisheries published an Advanced Notice of Proposed Rulemaking to begin the process for public comment on proposed modifications to the Fisheries Financing Program (FFP) to allow financing for new vessel construction under limited circumstances. Briefly, in response to increasing concern over the safety and environmental inefficiencies and an aging U.S. commercial fishing fleet, in fiscal year 2014 Appropriations, Congress increased the annual appropriation for the FFP and removed language prohibiting the use of its loans for the construction of any new fishing vessel that will increase the harvesting capacity in any United States fishery. Comments must be received on or before **July 30**.

### **Alaska**

#### **Bering Sea-Aleutian Islands Flatfish Rule - Open for Public Comment**

By **July 30**, submit your comments on a proposed rule to implement Amendment 105 to the Fishery Management Plan for Groundfish of the Bering Sea and Aleutian Islands Management Area. The amendment would establish a process for Western Alaska Community Development Quota groups and cooperatives established under the Amendment 80 Program to exchange harvest quota among three flatfish species.

#### **Proposed Steller Sea Lion Protection Measures - Open for Public Comment**

By **August 15**, submit your comments on proposed measures designed to prevent the groundfish fisheries in the Bering Sea and Aleutian Islands Management Area from jeopardizing the western distinct population segment of Steller sea lions. These protection measures would disperse fishing effort to minimize competition for prey between the fishery and the sea lions.

#### **Delisting of Humpback Whale Stock May Be Warranted**

NOAA Fisheries found that a petition to designate the Central North Pacific stock of the endangered humpback whale as a distinct population segment and to delist that population segment under the Endangered Species Act presents sufficient evidence to prompt a status review for the species. Please

## Pacific Islands

### Federal Fishery Managers Recommend New Annual Catch Limits, Other Measures

The Western Pacific Regional Fishery Management Council concluded its June meeting with recommendations regarding annual catch limits and other management measures for federally managed species in Hawaii, American Samoa, Guam, the Commonwealth of the Northern Mariana Islands, and the Pacific Remote Islands Areas.

## Greater Atlantic

### Changes in Forage Fish Affect Cod Distribution

A shift in the dominant prey species available to Atlantic cod in the Gulf of Maine led to a shift in cod distribution, a shift in fishing effort distribution, and, ultimately, to apparent conflicts between the 2011 assessment of the cod stock and the experiences of the fishing industry. As cod switched from preying on Atlantic herring to preying on sand lance, they concentrated their feeding in a small area on Stellwagen Bank where the sand lance burrow into the sand-and where fishermen could easily catch the cod in larger numbers.

### Recent Whale Entanglement Underscores Need for Management Actions

Canadian authorities have launched a search for an entangled North Atlantic right whale, first spotted by a NOAA Fisheries aerial team over the weekend at a distance too far for U.S. ship-based disentanglement teams to respond. This entanglement reinforces the need for recently strengthened precautionary measures to reduce the risks to large whales posed by fishing operations.

### Coastal Statistics Program Announces 2014 Projects

The Atlantic Coastal Cooperative Statistics Program-a state-federal partnership for marine fisheries data collection and management-has awarded nearly \$2 million to its partners for new and ongoing projects to improve data collection for coastal fisheries in 2014.

### Chesapeake Bay Managers Meet to Discuss Bay Science, Management

In June, state managers from around the Chesapeake Bay met for a 2-day series of presentations and discussion regarding striped bass, blue crabs, climate change, and plans for an upcoming workshop on forage fish.
