Sea Turtle Observer Requirement Determination

NOAA Fisheries published the [Final 2015 Sea Turtle Observer Requirement Annual Determination](#). We identified 14 commercial fisheries that will be required to take observers, if requested, for a 5-year period so that we can learn more about sea turtle interactions in these fisheries.

Baltic Sea Harbor Porpoise Does Not Warrant Listing

NOAA Fisheries announced a 12-month finding on a petition to list the harbor porpoise (*Phocoena phocoena*) in the Baltic Sea under the Endangered Species Act as an endangered or threatened distinct population segment. Based on the best available scientific and commercial information, the population does not meet the criteria for listing.

Alaska**New Study Tallies 20th Century Industrial Whaling**

A recently published journal article co-authored by NOAA Fisheries scientists and a researcher at the New Bedford Whaling Museum in Massachusetts provides the first global estimate of the number of whales killed by industrial whaling in the 20th century: an astounding 3 million whales.

West Coast**Retired Fisherman Recalls Days of Abundant Abalone**

Retired commercial fisherman and conservationist Ken Nielson grew up diving for abalone off the coast of southern California at a time when marine resources were plentiful and coastal development was minimal. Now, abalone populations are severely depleted, but there is hope for recovery.

Reef Fish Exempted Fishing Permit Application - Open for Public Comment

By **April 23**, please submit your comments on an application for an Exempted Fishing Permit from the Mississippi Department of Marine Resources. If granted, the permit would authorize the applicant to collect red drum in federal waters using Mississippi state licensed vessels. The study would collect data in waters where harvest is currently prohibited to support future stock assessments of red drum.

Scallop Exempted Fishing Permit Application - Open for Public Comment

By **April 7**, please submit your comments on NOAA Fisheries' consideration of an Exempted Fishing Permit allowing one commercial fishing vessel to fish outside of the limited access scallop days-at-sea program. The vessel would fish in support of research conducted by the National Fisheries Institute to investigate scallop incidental mortality during dredging.
