**THIS PRODUCT IS A REPORTABLE FOOD.**

Sysco Quality Assurance received notification that SIMPLY FRESH is conducting a voluntary product RECALL of CANTALOUPE Products.

The reason for the RECALL is the finished products tested positive for Listeria monocytogenes. There is a food safety issue.
